


# *ConnectMyHealth* PATIENT PORTAL PROJECT UPDATE

This month the Brantford Brant OHT Digital Health Working Group continued their support of the ConnectMyHealth (CMH) Patient Portal Implementation Project, led by Health Information Technology Services (HITS), a division of Hamilton Health Sciences.

In early April, the project team at HITS provided an update on the "soft launch" of CMH in their [Connections Newsletter](#), which included data from our local Brant Community Health System. As the project moves forward, the BBOHT will update our community partners in order to prepare for the launch of the program. Updates will include launch dates and patient registration information, as well as advertising and promotional ConnectMyHealth branded collateral to distribute in offices and other patient-facing environments.

ConnectMyHealth will be different than other patient portals because it combines various types of health records created at OH West hospitals into one, consolidated view. Key functionality of ConnectMyHealth includes record sharing, new information alerts, customizable patient dashboards and appointment timelines to easily display all upcoming appointments in one place. ## *ALYSSA STRYKER NAMED DRUGS STRATEGY COORDINATOR*

The City of Brantford is excited to announce the appointment of a new Drugs Strategy Coordinator. The Drugs Strategy Coordinator will work closely with the BBOHT and other community partners in order to lead the charge on drug strategy reform within the city.

Alyssa Stryker has over ten years of experience in drug policy, including direct service, research, knowledge translation and technical assistance. Alyssa began her career coordinating the casework portfolio at the British Columbia Civil Liberties Association in Vancouver, B.C. In her most recent role as a Senior Associate with the Substance Use Prevention and Treatment Initiative, Pew Charitable Trusts, she advised state and county governments on expanding access to opioid agonist therapy.

She also volunteered as an outreach worker with Honouring Individual Power and Strength, Washington, DC's main harm reduction provider.

Prior to Pew, Alyssa worked at the Drug Policy Alliance, where her work focused on reducing the criminalization of people who use drugs and issues related to low-level drug markets. Alyssa earned her Master of Arts in Human Geography from the University of British Columbia and also holds a Bachelor of Arts with Honours in Development Studies from Queen's University. ## *GRCHC OUTREACH STATION*

The Grand River Community Health Centre (GRCHC) is now able to provide a shower station and refreshment cart to those in the community who are experiencing homelessness or precariously housed. This program is funded by the Reaching Home Grant which was reviewed and supported by The City of Brantford's Community Advisory Board.

Shower access is by appointment only Monday-Friday, 9AM-4PM and can be booked in person at the GRCHC or by calling/texting 519-750-4932. Clients who have booked the shower station are also able to do their laundry or access "practical support" while they wait. This can include help with tasks such as completing forms or making appointments. This long-anticipated program is a huge step in the right direction for Brantford in providing meaningful support to those in need.



# WELCOME OHT IMPACT FELLOW!

The BBOHT is pleased to announce that Jennifer Miller has successfully been matched to the Brantford Brant OHT as part of the OHT Impact Fellow program through The University of Toronto. This program places skilled evaluators and researchers directly within OHTs for a year-long fellowship.
